By this time of year all gullies on A, B and C classified roads should have been cleared, but work has barely started due to the persistent heavy rainfall. It is recommended that Councillors report issues direct to highways in order to ensure that work gullies are cleared as the number of reports directly affects how quickly Highways attend to rectify problems. A resident of Ashleigh Court has raised concerns about the cars idling outside Londis and the Fish and Chip shop. However, the Council has no jurisdiction over such matters. PMcS will refer to the shop owners in the hope that they can encourage customers not to do this.</p> <p>Bus Service: Kirkby Lonsdale are not planning to introduce a Saturday service. However, the County Council is applying for £480k of Government funding and this may result in the service being revisited as part of the best use of funds.</p> <p>Plans are underway for the Cumbria to become a Unitary Authority. This will be driven by Central Government and is likely to take until 2022 to introduce.</p>
